395. Minutes of the meeting held on 6th February 2017 – it was resolved to approve the minutes as a true record.

396. Update from Allotment Administration Team

Canalside – Trees – update - Alan Will advised that the trees on Canalside have not been dealt with. Cllr Bromley will liaise with the college again to find out when works are to be carried out.

Should allotments only be offered to CV34 resident? Discuss – It was felt that as there was a waiting list that the allotments should only be offered to residents from CV34. If an allotment holder lived in CV34, when they had an allotment, could retain that allotment if they moved out of CV34 so long as the allotment was maintained, this decision was made as there was nothing in the rules to state this. The new rules will have a stipulation that

allotments are only available to CV34 residents.

Visit to Kenilworth Allotments – Liz to advise – Cllr Bolton, Liz and Vicky visited the allotments in Kenilworth. They have their own associate and run all aspects. Liz gave an overview of what was learnt and passed information around for members to consider. Moving forward the Councillors would like each allotment to form their own association.

The Percy allotment reps. were open to being trialled first.

Guy's Cliffe – fire damage on greyhound racetrack – discuss. It was determined that the wire fence needed to be replaced. Liz to visit to find out if the fence was on our boundary or WCC.

Percy – fence repaired – reps were happy with the replacement fence.

397. Rules and Regulations

Members were provided with a copy of the rules used by Kenilworth Allotment Association for consideration. Feedback was requested asap to incorporate into revised Rules & Regulations document with a view to them being agreed at the meeting in June. Starter plots to have a time restriction included.

It was felt that approx. 10% of plots are not being cultivated to a satisfactory level. Site Inspector and Admin Team to keep a tight control on non-cultivated plots. There are 30 people on the waiting list, 6 of these would be likely to take a plot on the Percy.
