**TOWN POLICE CLAUSES ACT 1847, SECTION 21**

**THE WARWICK DISTRICT COUNCIL (WARWICK HALF MARATHON)  
(TEMPORARY PREVENTION OF OBSTRUCTIONS IN STREETS) ORDER 2018**

WHEREAS the Warwick District Council ("the Council") is of the opinion (*that the roads in the schedule below in Warwick, Leek Wootton, Hatton and Budbrooke*) will be thronged or liable to be obstructed due to public processions, rejoicings or illuminations.

NOW THEREFORE the Council, in exercise of its powers under section 21 of the Town Police Clauses Act 1847, hereby makes the following Order:-

1. This Order shall come into operation on 4 March 2018 and may be cited as "The Warwick District Council (Warwick Half Marathon) (Temporary Prevention of Obstructions in Streets) Order 2018".
2. No person shall cause or permit any vehicle, except upon the direction or with the permission of a police constable in uniform, to proceed along the roads *in schedule below* on Sunday 4 March 2018 between 8am and 2pm.
3. Every wilful breach of this Order shall be deemed a separate offence against the Town Police Clauses Act 1847, and every person committing any such offence shall be liable to a penalty not exceeding level 3 on the standard scale.

**C24 Rouncil Lane** (Kenilworth / Leek Wootten) from the junction of Woodcote Lane to Red House Farm Lane; 08:30 – 11:00  
**D5076 Red House Farm Lane** (Leek Wootten) from the junction of Rouncil Lane to Beausale Lane; 08:30 – 11:15  
**D5078 Beausale Lane** (Leek Wootten) from the junction fo Red House Farm Lane to Brownley Green Lane; 08:30 – 11:30  
**D5078 Brownley Green Lane** (Hatton) from the junction of Beausale Lane to Birmingham Road; 08:30 – 11:30

**A4189 Hampton Street** (Warwick) from the junction with Hampton Road to Bread and Meat Close; 08:30 – 14:00.
