- **40. To elect Chairman for the Municipal Year 2021/22-** Cllr J Tracey was nominated all were in favour there were no other nominations received.
- **41. Apologies:** Councillor Mrs M A Grainger & Councillor T Morris. It was resolved to accept their apologies.
- 42. Declarations of Personal and Prejudicial Interests none
- **43. Minutes of the meeting held on 20<sup>th</sup> May 2021** minutes approved and signed. It was resolved to accept the minutes as a true record of the meeting. 302 precept calculations a meeting will be arranged, with Cllr N Butler, Town Clerk and Andrew Rollins WDC, to review.

- **53. Asset of Community value Punch bowl public house –** the application was deferred to a community group who will be putting in the application.
