- **369.** Apologies: There were no apologies.
- **370. Declarations of Interest** None
- 371. Approve the Minutes of the Finance & Policy Committee Meeting held on 12th March 2020.

It was resolved to approve the minutes as a true record of the meeting.

- **372.** Schedule of Accounts already paid/Income March 2020. It was resolved to Approve the Income and expenditure payments.
- 373. Actual v Budgets 2019/2020 report attached for information. The overall income was £16K higher than expected and the expenditure £11k less. Councillors raised queries around overspending in some areas, which were clarified. Final figures will be issued through Management Accounts produced by the Accountant which show an increase reserves of £78K making total reserves £178K.

The layout of future reports will show a column stating variance and variance percentage and explanations of substantial overs and unders.

374. As a result of the Covid 19 pandemic - Revised budgets for 2020/2021

The proposed figures were reviewed. It was resolved to reduce Christmas lights expenditure by £3k and move this money to the TIC refurbishment to allow the project to progress and also defer the £3k set aside in the Town Centre

Management budget for Information packs and use this money for a project to regenerate Warwick following "Lock down". All the other figures proposed were agreed.

- **375**. **Staffing** The Town Clerk gave Councillors a resume of the effect that Covid 19 had had with regard to working patterns and also plans in place once "Lock down is lifted.
- **376.** Paperless next steps There had not been a meeting therefore this item was deferred.
- 377. To approve an amendment of the powers of Finance & Policy committee.

It was resolved to approve this change. Cllr N Butler advised that the detail will be laid out in an Investment Policy that will be brought to this committee in June 2020.
