- **277.** Approve the Minutes of the Council Meeting held on 2nd December 2019 It was resolved to approve the minutes as a true record of the meeting.

278. Reports of Committees

To receive and adopt the minutes of the Finance and Policy committee meeting held on the 9th January 2020.

Cllr Morris reviewed the minutes he asked for two Councillors to join Cllr Darcy and Cllr Grainger to review the Town Councils ability to become paperless. Cllr Birdi and Cllr Jacques will join. The Town Clerk will organise a meeting. Cllr Morris also reiterated the point raised regarding "apologies" drawing Councillors attention to the need to email the Town Clerk with a reason for absence and allowing 48 hours' notice with a view to finding a "sub" and advising the Leader of the Council.

The Town Clerk raised the item discussed regarding Seven Trent's request for there to be a Grease Trap installed in the kitchen – she had contacted Environmental health and they had advised that we should go ahead to avoid a fine. Therefore, Councillors agreed for the works to be carried out.

It was resolved to accept the minutes from the Finance and Policy Committee on the dates stated.

279. Estimates and Precepts 2020/21 – determine precept requirements. Cllr Morris gave a comprehensive background to the discussion held at Finance

and Policy meeting and the rational to their 25p per month proposal.

The main reasons being – the Tourist Information Centre revamp. Increasing reserves. NALC salary increased proposed at a 5% minimum. WDC rent reviews of rooms rented in Pageant House. Ongoing maintenance of the Grade 1 listed Court House.

It was resolved to increase the precepted amount by 25p per month taking the annual figure to £36.79 for a band D property.

- **281.WDC Consultation** Affordable Housing supplementary planning Document Cllr Cross gave an overview of the document following a discussion it was resolved to approve support to the document.
