WCC Cllr J Darcy advised Councillors of the following WCC initiatives:

Levelling up – focusing on Inequality & Education and Health inequalities.

WCC Cllr J Holland advised Councillors of the success of the Folk Festival in Warwick. An overview of the access rights during the Commonwealth games cycle race was given. Commenting on Devolution Cllr Holland stated his feedback to WCC regarding the importance of Town and Parish Council inclusion.

Market Hall Museum – opening times are being changed to bring them in line with the Visitor Information Centre.

Cllr T Morris asked a question regarding the cycle race – with the removal and reinstallation of the speed bumps – who is paying for this cost. Clarification will be sort by Cllr Holland. Cllr Skinner asked if the questions raised at E & T regarding the cycle race had been answered. Cllr Butler clarified about the train routes into Warwick and Cllr Edgington advised that answers were shared via a Chamber meeting. The Town Clerk will share this correspondence.

Warwick Nursery is having its funding cut – the Town Council were asked to write in support.

WDC Cllr Mrs MA Grainger – gave an overview of the 123 + collection changes starting in August 2022.
