- **336. Avon Navigation scheme Socioeconomic effects and environmental impact** there have been long standing proposals for a through navigation of the River Avon from Alverston Weir to Warwick. Peter Brett Associates have been commissioned to review the Socioeconomic effects and environmental impact of the proposed scheme. Councillors can see a benefit to Warwick with proposed tow paths for cycling and walkers.
