Planning number	Application	Warwick Town Council's comments
W/18/0910	Racecourse	Warwick Town Council would like to support the objection raised by LLFA and also ask if the flood mitigation plan considers the impact on local residents at Chase Meadow. They are not impressed by the size and design of the structure and feel that it would be an "eyesore" on the approach to Warwick
W/18/0893	Warwick Castle	Warwick Town Council are shocked that planning permission was not sort before such changes were made. The rose garden was Warwick's Link to Princess Diana and should be restored maintained in the condition of the official opening.
W/18/0958	Shop and premises, 170 Emscote Road	Warwick Town Council object to this application reiterating the comments made when objecting to W/18/0659 - they consider this to be an overdevelopment with insufficient parking.
