W/18/1757 & 1758 & 1756 & 1759	McDonalds - Land at Tesco Supermarket	Warwick Town Council objects to this application as there is no restaurant approved therefore the signage is not necessary. There is a restriction on signage along the Emscote Road which was agreed when the Tesco Supermarket application was approved.
W/18/1760	19 Pickard Street	Warwick Town Council objects to this application in support of the concerns raised by Highways. They objected to the original applications for dwellings due to parking. This is overdevelopment of the site it effects the street scene – an officer needs to carry out a site visit
W/18/1646	Warwick Hospital	Warwick Town Council object to this application in support of the comments made by Highways.
W/18/1537 & W/18/1529LB	24 Mill Street	1537 - Warwick Town Council objects to this retrospective application due to the effect on neighbouring properties. 1529 - Warwick Town Council objects to this retrospective application due to the incorrect materials being used.

170. Warwick Castle – update on Masterplan and Maze. Mr M Halford spoke to Councillors firstly giving a background to how decisions were made at the Castle pointing out the fact that Merlin (Owners) did not influence conservation decisions that the Core Management Team were the instigators of future change at a local level. The Master Plan is being reviewed working with Warwick District Council, once finalised Mr N Blofeld will present again to this planning committee, likely to be before the end of the year.
